

X2Power Lithium Batteries with Bluetooth® Limited Warranty



X2Power® lithium iron phosphate (LiFePO₄) battery products with Bluetooth enabled communications, designed for deep cycle applications only, are covered by a limited warranty against manufacturing defects. The warranty coverage available is a free replacement period only from date of purchase. Should the battery fail due to a manufacturing defect within the free replacement period, the battery will be replaced at no cost with a new battery of comparable performance. Batteries replaced during the free replacement period will continue to be covered by the original warranty from the original purchase date.* Cash reimbursement is not available. The following batteries are covered by the limited warranty for a period of Ten (10) years or 2000 cycles whichever is earlier. X2P12-20MLI-BT, X2P12-50MLI-BT, X2P-24MLI-75-BT, XP-27MLI-100-BT, X2P-31MLI-125-BT, X2P-24VMLI-60-BT, X2P-36MLI-40-BT, X2P-12-35LI-BT, X2P-24MLI-100-BT, X2P-27MLI-125-BT, X2P-31MLI-150-BT

**Only one free replacement is allowed through the original battery purchase and receipt.*

Warranty Protection is Subject to the Following Guidelines:

- A warranty claim may require product analysis and/or charging prior to issuance of a replacement, which may take up to two (2) business days to process.
- Warranty coverage is not transferable (it applies to the original purchaser only), and requires a proof of purchase or original receipt.

- If the Full Charge Capacity (FCC) reported by the App, when the battery is fully charged, is less than 80% of the rating, and before the end of the warranty term, the battery will be considered for warranty.
 - Warranty coverage applies to original application only. A battery used in multiple applications voids the warranty.
 - The warranties for the specific products are the exclusive and the only warranties that we provide with respect to the products we sell.
 - Batteries should be paired with a suitable charger designated for the technology and rating of the model selected. Incorrect selection of charger and/or failure to follow the correct charging regimen will void the warranty. Only use a charger without a desulfation mode. Overcharging the battery may result in irreversible damage.

- Discharged batteries that can be recharged and returned to service.
